I.INSTRUCTIONS TO BIDDER.

1. GENERALS

- (a) Bidders are advised to study the Bid Document carefully. Submission of the Bid shall be deemed to have been done after careful study and examination of all instructions, eligibility, forms, terms and requirement specifications in the tender document with full understanding of its implications. Bids not complying with all the given clauses in this tender document are liable to be rejected. Failure to furnish all information required in the tender Document or submission of a bid not substantially responsive to the tender document in every respect will be at the vendor's risk and may result in the rejection of the bid. Incomplete tender is liable to be rejected. Contracts envisaged under this contract are required to be executed in all respects up to the period of completion mentioned above.
- (b) All the Bids shall be prepared and submitted in accordance with these instructions.
- (c) The Bidder should quote for all the items mentioned in the **Annexure-I.**
- (d) The Bid should be submitted by the Bidder in whose name the bid document has been issued and under no circumstances it shall be transferred/ sold to the other party.
- (e) The Bidder is expected to examine all instructions, forms, terms & conditions and specifications in the Bid Documents. Failure to furnish all information required in the Bid Documents or submission of a Bid not substantially responsive to the Bid Documents in every respect may result in rejection of the Bid. However, the purchaser decision in regard to the responsiveness and rejection of bids shall be final and binding without any obligation, financial or otherwise, on the purchaser.
- (f) Only those agencies, who fulfil the Eligibility and Qualification requirements for Bidders should submit the tender documents.
- (g) ICAR-CCRI reserves the right to accept/reject any or all Tenders without assigning any reason thereof and alter the amount and quantity mentioned in the Tender documents at the time of placing Work orders.
 - 1. Tender Earnest Money Deposit (EMD) of value INR Rs.42,500/- (Rupees Forty-Two thousand Five hundred only) in shape of Bank Draft in favour of ICAR unit CCRI, payable at Nagpur.
 - 2. Complete Technical and financial bids should be submitted in two envelop separately.
 - **3.** The successful bidder shall submit performance bank guarantee after notification of award and before signing the contract. The amount of performance bank guarantee shall be 5% of contract value for a period of 15 months.

2. Availability of tender

1. Eligibility and Qualification requirements for Bidders:

- I. The bidder must possess the requisite experience, strength and capabilities in providing the services necessary to meet the requirements, as described in the bidding documents. The bidder must also possess the technical know-how and the financial wherewithal that would be required to successfully provide the support services sought by the CCRI/ICAR, for the entire period of the contract. The bids must be complete in all respect and should cover the entire scope of work as stipulated in the bidding document. The bidder should meet the eligibility criteria as given below:
- II. **Eligibility for participation:** The prospective bidder must qualify all of the following requirements to be eligible to participate in the bidding.
- III. To fulfil the technical requirements of the tender, self-attested scan copies of the documents should be submitted as per Annexure V

2. Cost of Bidding

The Bidder shall bear all costs associated with the preparation and submission of its bid, and the Purchaser will in no case, be responsible or liable for those costs.

3. Price format

- I. Price currency is Indian Rupee. i.e. INR
- II. Price should be quoted with applicable taxes i.e. GST etc. All taxes shall be applicable as per notification of Govt. at the time of bill/invoice.

Terms& Conditions

1. Security & Payment:

- i. The successful bidder will have to deposit Security Deposit equal to 5-10% of the total value of the contract further reduced to the extent of Earnest Money Deposit which will be accordingly adjusted and also execute the contract within 30 days from the date of placement of order. If the firm fails to provide services to the satisfaction of the Institute as per the order during contract period, the contract will be cancelled and the Security Deposit will be forfeited or Bank Guarantee revoked. The Security Deposit will be released after completion of the contract to the satisfaction of the Institute.
- ii. The Successful tenderer will have to sign an Agreement with the Institute on a non-judicial stam paper of appropriate value before taking over the contract.
- iii. No advance payment will be made. The vendor can take six monthly payments subject to submission of bills. The payment shall be released on satisfactory completion of assigned services. Income Tax and other taxes as per rules will be deducted from the bill as applicable from time to time

4. Evaluation of bid

- a. PROCESS TO BE /CONFIDENTIAL: Information relating to the examination, clarification, evaluation and comparison of bids and recommendations for the award of a contract shall not be disclosed to bidders or any other persons not officially concerned with such process. Any effort by a bidder to influence the purchaser's processing of bids or award decisions may result in the rejection of the Bidder(s) Bid.
- b. CLARIFICATION OF BIDS: To assist in the examination, evaluation and comparison of Bids, the Purchaser may, at its discretion, ask the Bidder for a clarification of its Bid. All responses to requests for clarification shall be in writing and no change in the price or substance of the Bid shall be sought, offered or permitted.

c. PRELIMINARY EXAMINATION OF BIDS / RESPONSIVENESS

- i. The work will examine the bids to determine whether they are complete, whether any computational errors have been made, whether required its Securities have been furnished, whether the documents have been properly signed, and whether the bids are generally in order.
- ii. Prior to the detailed evaluation, the work will determine the substantial responsiveness of each bid to the bidding documents including production capability and acceptable quality of the Goods offered. A substantially responsive Bid is one, which conforms to all the terms and conditions of the Bidding Documents without deviation.

d. EVALUATION AND COMPARISON OF BIDS

- i. A duly constituted committee will evaluate the technical bids. EMD and technical bid of the tender will be opened in the first instance. ICAR-CCRI reserved the right to seek fresh set of documents or seek clarification on the already submitted documents.
- ii. The evaluation of Bids shall be done based on the Eligibility Criteria, Financial Lowest Cost Basis Selection (LCBS) and competitiveness basis. The bids will be opened in two bidding i.e. Technical bid and financial bid as per procedure. In the event of the specified date of bid opening being declared a holiday for ICAR-CCRI, the bids shall be opened on the next working day.
- iii. The evaluation of the Bids shall be a stage-wise procedure. The following stages are identified for evaluation purposes: In the first stage, the Bids would be subjected to a responsiveness check for eligibility for participation. The responsive bidders of First stage shall be eligible for technical evaluation.
- iv. Bidders shall base their Bid price on the terms and conditions specified in the Bidding Documents.
- v. The work will evaluate and compare the bids that have been determined to be substantially responsive. The evaluation will be performed assuming that:
- (a) The Contract will be awarded to the lowest evaluated Bidder for the entire Tender.
- (b) The Works evaluation of a bid will be made on the basis of prices quoted in accordance with Bid Prices.
 - a. The competent authority of the Institute shall have the right to reject all or any of the offers, accept more than one offer and assign part of the job.
 - b. A Demand draft of Rs. 42,500/- as Earnest money in favour of ICAR Unit CCRI, Nagpur is to be enclosed along with the quotation. No Quotation shall be considered without the earnest money deposit. The earnest money will be refunded only after the finalization of the contract and no interest will be paid on earnest money. However, exemption will be given for the firm having registration certificate issued by National and Small Industries Corporation (NSIC), MSME etc. for the purpose under contract.
 - c. In case of violation of any terms and conditions on the part of the firm is noticed and/or the services are found unsatisfactory, performance security can be forfeited at the discretion of the Competent Authority in the Institute. Further, in case the complaint is not attended to promptly within the specific time, the work will be got done from other sources at the contractors risk and cost. In this regards the decision of the Competent Authority in the Institute shall be final and binding on the contractor.
 - d. Rates once finalized will not be enhanced during the currency/period of the contract.
 - e. If the contractor is not able to rectify the fault within the stipulated period of maximum of three days, it would be open to this office to have the fault rectified through any our source and contractor shall have to bear the expenses so incurred on this account.
 - f. The contract may be considered for extension by mutual consent and for such further period as may be agreed upon subject to proper services provided by the firm and approval of the competent authority in the Institute.
 - g. The competent authority in the institute reserves the right to cancel the contract at any time during the currency/period of the contract without giving any reason.
 - h. Mere quoting lowest rates will not amount to commitment for award of contract. L-1 will be selected on the basis of lowest combined total as per Annexure-I.
 - i. If any dispute(s) arises between the Institute and the firm with reference to the contract, the Director of the Institute will decide and decision will be binding on the firms.

II. Risk & Expense clause

In event of the Vendor failing to honour contractual obligation within stipulated period risk offloading will be invoked by ICAR-CCRI at the expense to the Vendor. Whenever, the risk offloading is restored to, the Vendor is liable to pay the additional amount spent by the Institute.

OTHER TERMS AND CONDTIONS:-

- 1. The successful firm shall **commence work** within 90 days from the date of confirmed **work order** and if the work not supplied in time then EMD shall be forfeited. The rates quoted shall be valid for one year from the date of opening of tender.
- **2.** All costs including as per govt. norms costs, GST, installation costs etc. to be included in final total costs. No extra or other costs to be given separately.
- 3. Tenders should be submitted in two bid system i.e. technical bid and financial bid. Financial bid shall be open of those firms who have qualified in technical bid.
- 4. Firm/ companies/ manufacturer should have registered with NSIC or MSME.

Technical Specification for the Renovation work to be undertaken for converting existing old auditorium to Video Conferencing Room at ICAR-CCRI, Nagpur

Specification of Renovation work to be undertaken for converting existing old auditorium.

Modification & Civil Work

- 1. Fully Vitrified Floor Tiles of Branded and good quality would be pasted on existing floor with top-grade, ISI mark tile -adhesive or superior quality material. Tiles area (12.010 mtr X 5.900 mtr) or 762.79 Sq feet with thickness of 10-12 mm
- 2. Dismantling at Wall (a wall between Hindi Cell and Auditorium hall) to open entry Door (700 mm width) to Wash-room. Dismantling of existing wall racks (a wall that has door) in conference hall. Removing 4 Nos. existing windows. The repaired/removed portion of the wall shall be reconstructed with brick work, cement plaster and colour wash of the entire wall to even shade with approved brand of plastic emulsion.
- 3. Complete Glass Shutters to entry & exit opening including lock security arrangements
- 4. (2x1.18x2000) = 4.72 Sq.mt [4.72x10.765] = 50.80 Sq feet.
- 5. Gypsum in ceiling as per design in area $[5.90 \times 12.010] = 4.725$ q.mt = 50.80 Sq feet
- 6. Internal Painting to remaining portion of walls & ceiling as per theme.
- 7. Painting to the exterior front portion of conference hall .[1x12.46x3.00] = 37.38 Sq.mt
- 8. [37.38x10.765)=402.3957 Sq. feet
- 9. Sound Proof UPVC Windows good quality- 4 Nos.

CIVIL WORK (Pantry Section attached to Hindi Cell):

- A) Modification & Civil Work.
- **B**) To separate the washroom & pantry section attached to the Hindi Cell, the existing door on the common wall between washroom & pantry section has to be removed and closed with wall. One Entry Door (700 mm) has to be made / constructed in pantry section so as to convenience in movement between VC Hall & Pantry.
- C) All plumbing point to be connected from washroom area, disposal of kitchen sink towards wash area.
- **D**) A rack available in the Pantry section needs to provide with laminated shutter to so that it could be converted to cupboard.
- E) Provision of kitchen counter, granite top, one sink provision, sink pillar taps, plumbing work.
- **F**) Necessary internal painting to all walls and ceiling.
